14. Apologies for Absence

Apologies for absence had been received from Councillors Chapman, Cooper, Mrs Goad and Nash.

15. <u>Declarations of Interest</u>

The Monitoring Officer has advised Members of interim arrangements to follow when making declarations of interest. They have been advised that for the reasons explained below, they should make their declarations on the same basis as the former Code of Conduct using the descriptions of Personal and Prejudicial Interests.

Reasons

- The Council has adopted the government's example for a new local code of conduct, but new policies and procedures relating to the new local code are yet to be considered and adopted.
- Members have not yet been trained on the provisions of the new local code of conduct.
- The definition of Pecuniary Interests is narrower than the definition of Prejudicial Interests so, by declaring a matter as a Prejudicial Interest, that will cover the requirement to declare a Pecuniary Interest in the same matter.

There were no declarations of interest made.

16. Minutes

The Minutes of the meeting held on 31 July 2014 were approved by the Subcommittee and signed by the Chairman as a correct record.

17. <u>Arun Local Plan Update</u>

Prior to consideration of the report and the accompanying background papers, the Principal Planner provided the Subcommittee with a verbal update on the current status of the Transport Studies. She advised that the Enterprise Bognor Regis Felpham link study had been completed and was available on the Council's website. The results had favoured Option 1, which would remain east of the railway line and so a bridge would not be required and would cost significantly less than the Option 2 route.

With regard to the Employment and Enterprise Validation Study the Principal Planner was able to advise that this was nearing completion and would be uploaded to the website in the near future.

The Chairman then sought the Subcommittee's approval to consider and vote on Parts A, B, C and D as separate entities, which was duly agreed.

Part A: An evidence base update which presented the Authorities Monitoring Report; Housing and Economic Land Availability Assessment; Housing Land Supply; and Housing Implementation Strategy.

- Authorities Monitoring Report –The Head of Planning Policy & Conservation advised that information was still awaited from the County Council regarding Commercial Delivery and from the Sussex Biodiversity Records Centre on the Sussex Biodiversity report.
- Housing & Economic Land Availability Assessment (HELAA) Sites,—The Head of Planning Policy & Conservation advised that this paper merged the Housing and Employment Sites Assessment into one resource, in line with best practice and planning policy guidance. The Subcommittee was also informed that, following the successful Yapton Neighbourhood Plan referendum, the density figures of two sites would be increased (Items 6 and 8 on page 44 of the agenda) and two would be deleted (items 7 and 9), with the net result being an uplift in numbers which would help with the Council's housing land supply. The changes would be made to the HEELA and related documents following Full Council on 5 November 2014.
- Housing Land Supply The Head of Planning Policy & Conservation advised that this was a critically important aspect of the Authorities Monitoring Report and differed to that previously presented due to changes in planning policy guidance, with the key outcomes being detailed on page 57 of the agenda.
- Housing Implementation Strategy The Head of Planning Policy & Conservation advised that the purpose of this paper was to show what contingencies had been made to underpin the Local Plan should any sites not come forward or come forward less quickly in the future.

Part B: Assessments to support the soundness of the Local Plan, namely the Equalities Impact Assessment and an assessment required under Section 17 of the Crime & Disorder Act.

- Equality Impact Assessment As the Council had adopted an Equality Impact Assessment procedure, it was considered that every policy in the Local Plan should be assessed. Most policies were scored neutrally, with the housing score being positive in policy areas such as affordable housing but with a negative score for Travellers until the Traveller Site Specific Development Plan was adopted.
- Section 17 of the Crime & Disorder Act The Head of Planning Policy & Conservation advised that the policies in the Local Plan had been assessed against crime and disorder issues. The Safer Arun Partnership had worked with the Council throughout the development of the plan and had formally endorsed this assessment on 1 September 2014.

Part C: Draft Duty to Cooperate Statement; and Duty to Cooperate Correspondence.

Draft Duty to Cooperate Statement – The Senior Environmental Assessment Officer presented this paper and stated that, as part of the Localism Act, the authority needed to produce a Statement about how it would meet the requirement for the Duty to Cooperate. It was further stated that what was on the table was very much in draft form and it would be brought up to date prior to the Examination in Public. Members were requested to feed back their comments to Charlotte Hardy, the Senior Environmental Assessment Officer.

Members participated in some debate on this matter, particularly around attracting people from the wider area back into Arun and cutting down on travel to outside of the District by providing high quality jobs and regenerating areas within Arun. There was also some debate over issues relating to housing, incorporating the acknowledgement that the 'Duty' was a complex matter which did not recognise administrative boundaries.

Duty to Cooperate Correspondence – Part A – Memorandum of Understanding between Arun District Council and Mid Sussex District Council. The Head of Planning Policy & Conservation advised that the relevant Portfolio Holders had met and agreed the MoU in principal. The Council was not committed to anything in signing the MoU but it was equally beneficial for Arun and Mid Sussex to formalise their collaboration.

Part B – Officer response to Crawley Borough Council's Duty to Cooperate letter. The Head of Planning Policy & Conservation

Subject to approval at the next Subcommittee meeting

advised that a response was necessary to Crawley's request for help with their employment and housing needs.

Part C – Statement of Common Ground with Lewes – officers were of the view that it would be beneficial for the Council to sign up to this and agreed with the evidence that was being put forward.

Part D: Response to Crawley Submission Local Plan and Planning & Traveller Consultation.

- Response to Crawley Submission Local Plan The Head of Planning Policy & Conservation stated that it was considered that the approach being taken by Crawley Borough Council was a sensible one.
- Planning & Traveller Consultation The Principal Planner introduced the consultation by saying that on 14 September 2014 the Government had published proposed changes to the national planning policy for Traveller Sites. She explained that the consultation particularly focussed on the following themes:-
 - Promoting fairness in the planning system the consultation aims to achieve this by amending the definition of 'gypsies and travellers' and 'travelling showpeople' by removing "or permanently" from the sentence "Persons of nomadic habit of life whatever their race or origin, including such persons who on grounds only of their own or their family's or dependants' educational or health needs or old age have ceased to travel temporarily or permanently....."
 - Protecting sensitive areas and the Green Belt the consultation aims to achieve this by providing additional protection to sensitive areas including Green Belt and National Parks
 - Addressing the Unauthorised Occupation of Land the consultation aims to achieve this by requiring that unauthorised occupation of land is used as a material consideration against an applicant when they make an application
 - Finally, the consultation requests comments on the Draft Planning Guidance for Travellers, to be included in the Planning Practice Guidance

It was reported that the draft officer response had been prepared in consultation with the Development Control Team Leaders for the Eastern and Western Areas as they had experience in dealing with Gypsy and Traveller applications and had an understanding of the sites in the District.

Subject to approval at the next Subcommittee meeting

The Principal Planner directed Members to the draft response to Question 1 with regard to the proposed amendment to the definition of Travellers. She highlighted that the proposed amendment could add unnecessary complexity to the planning process; could lead to delays to the decision making process; and could result in an increase in enforcement cases. Furthermore, the definition could lead to increased uncertainty for traveller families who intended to continue to travel but their circumstances, such as integrating children into local schools, prevented them from travelling.

The Subcommittee was requested to consider the officer's draft consultation response and, in the course of discussion, Member comment was made regarding Section 2 within Annex A - Draft Planning Guidance for Travellers" which stated that "Local Authorities should take account of travellers accommodation needs which related to their preference for mixed use caravan sites" and it was agreed that, as this term was not clear that would be noted in the consultation response. It was also agreed that Question 1 relating to the deletion of the words "or permanently" from the planning definition of travellers, should be left unanswered as it was not clear what the implications would be either with or without it.

EXECUTIVE SUMMARY

There have been various consultations from neighbouring authorities and also Network Rail since the last meeting.

Those relevant to this Sub-Committee are the Proposed Modifications to the Brighton and Hove City Plan; the Adur Proposed Submission Local Plan; Mid Sussex District Council's District Plan consultation draft and; Network Rails Draft London and South East Route: Sussex Area Route Study consultations.

This report contains brief summaries of the main contents of each and the proposed Officer response.

RECOMMENDATION

The following actions are recommended:

 That the Local Plan Sub-Committee recommends to Full Council that the officer responses to various consultations set out in this report are agreed. Any minor changes to be agreed by the Portfolio Holder and Assistant Director Planning and Economic Regeneration.

1.0 BACKGROUND

1.1 The Council is consulted as a statutory consultee on the various stages of the production of Local Plan's being prepared by both immediate neighbouring authorities and within the wider area. Since the last committee meeting there have been a further

- three consultations that the Council have been invited to respond to.
- 1.2 The Council has also been invited by West Sussex County Council to respond to Network Rails consultation on the draft London and South East Route: Sussex Area Route Study.

2.0 CONSULTATIONS

- 2.1 Therefore the Council has been invited to respond to 4 consultations. Namely:
 - Proposed Changes to the City Plan (Brighton and Hove City Council)
 - Proposed Submission Adur Local Plan (Adur District Council)
 - Consultation Draft District Plan (Mid Sussex District Council)
 - Network Rails draft London and South East Route: Sussex Area Route Study

Proposed Changes to the City Plan (Brighton and Hove City Council)

- 2.2 This consultation runs for 7 weeks from 4th November until 16th December 2014. This proposes a number of changes to the City Plan, to be termed 'Proposed Modifications'. These have resulted from further work that has been carried out responding to concerns that the Inspector had raised. The main areas these changes focus on are:
 - 1. The City's Housing target;
 - 2. Identification of the urban fringe as a broad source of potential for housing;
 - 3. The Brighton Marina policy; and
 - 4. The Sustainable Building policy.
- 2.3 Brighton and Hove has been a partner in the production of a number of joint pieces of evidence relating to the Housing Market. The studies take into account the constraints the City has and recognise that due to these constraints, the figure within the submitted plan of 11,300 did not meet the objectively-assessed development need of between 800-1000 homes per year. This figure was based on the 2012 SHLAA Update.
- 2.4 A review of the urban fringe sites was carried out which has considered capacities. As a result of this exercise an additional capacity of 1,900 units has been found to contribute towards the delivery of housing. Overall, it is now intended that 13,200 new homes will be delivered by 2030. It must be recognized however that this remains approximately 5000 units below the lower target for Brighton and Hove's objectively assessed needs.
- 2.5 66 sites have been considered for additional housing. 5 were excluded on the basis that they were covered by absolute constraints and site

visits were then carried out on the remaining 61 sites. The sites were reviewed in terms of their appropriateness for housing, what densities may be achieved and what mitigation may be required. As a result 39 sites were identified as having potential to accommodate housing. These correlated to the west, north and south of the City, with few in the east due to the greater number of constraints.

- 2.6 The standards within the Sustainable Buildings policy and parts of its supporting text have also been modified, as a reflection of the changed national position. This also clarifies that any further changes will be incorporated into Part 2 of the City Plan. Other more minor alterations throughout the document are included to reflect these changes.
- 2.7 The proposed response is attached as Background Paper 1.

Proposed Submission Adur Local Plan (Adur District Council)

- 2.9 This consultation is on the Proposed Submission Adur Local Plan and is for a period of 6 weeks from 20th October to 1st December. This forms the Regulation 19 stage which is carried out on behalf of the Planning Inspectorate, before being submitted for Examination in Public.
- 2.10 Changes to the Local Plan include a review of the gaps and built up areas where there has been some limited alteration to some of these. There has been a minor increase in the housing numbers, although this remains below the objectively assessed needs. The Local Plan and the supporting documents make clear what the constraints and deliverability issues are, as well as the joint working that has been carried out to deal with and address this expected shortfall against the objectively assessed needs.
- 2.11 The proposed response is attached as Background Paper 2.

Consultation Draft District Plan (Mid Sussex District Council)

- 2.12 This consultation is with respect to a Draft District Plan, containing all of those areas where Mid Sussex District considers no issues remain. This is an 8 week consultation that runs from 21st November until 16th January 2015.
- 2.13 The main aim of this consultation is to provide residents and stakeholders with the opportunity to comment on updated wording for the text and policies that it contains, as some have been significant since the last round of consultation. These have resulted from responses and discussions with professional and statutory bodies.
- 2.14 This consultation does not include any housing numbers, although it does allocate land for development at Burgess Hill. The housing

number will be set once all of the technical work on need and capacity has been undertaken and discussions with neighbouring authorities are concluded. There will be a chance to comment on these elements of the Plan when formally published in May 2015.

2.15 The proposed response is attached as Background Paper 3

Draft London and South East Route: Sussex Area Route Study (Network Rail)

- 2.16 Network Rail is currently consulting on the draft London and South East Route: Sussex Area Route Study. The consultation is running for 90 days and will close on 13th January 2015.
- 2.17 The study sets out a strategy for the Sussex area which forms part of the devolved South East route and covers the Brighton Main Line and connecting routes. The study will set the strategic direction for future investment in the Sussex Area Route rail network.
- 2.18 West Sussex County Council are considering the key issues for West Sussex to highlight in its response to Network Rail and has asked for the views of the local authorities in West Sussex and also other organisations such as rail user and community organisations to help inform its response.
- 2.19 The Council has provided an officer response to WSCC which is based on the matters emanating from the Leisure, Tourism and Infrastructure Working Group held earlier this year. This response is attached as part 1) of Background Paper 4.
- 2.20 The Council would also like to respond to Network Rail directly with some more detailed comments from Members who were asked for their views to inform this response. This proposed response is attached as part 2) of Background Paper 4.



<u>Background Paper 4 - Responses to the Draft London and South East Route:</u> <u>Sussex Area Route Study (Network Rail)</u>

1) <u>Below is the Officer response provided to West Sussex County Council to</u> help inform their response to Network Rail:

Thank you for seeking Arun District Council's views on the Network Rail consultation: Draft London and South East Route: Sussex Area Route Study.

Set out below are Arun District Council's comments relating to the improvement of railway infrastructure in the area for consideration by Network Rail.

- 1) Arundel Chord the Council would welcome investigation of whether the Arundel Chord could be used permanently as a regular route to London, with the potential journey saving time from Littlehampton to London of 20 minutes.
- 2) The Council would like to see improvements to the train services from Bognor Regis and Littlehampton to and from London in terms of duration, direct routes and timely availability with investment directed to Arundel and Ford to aid accessibility to and from London for residents of Bognor Regis and Littlehampton. The fast line to Brighton is considered slow.
- 3) The Council is keen for engagement from Network Rail regarding level crossings as it would like to see the removal of level crossings, where possible, and increased safety features such as pedestrian crossing bridges.
- 4) There is a need for additional car parking and a need to improve the existing car parking situation at Ford station. The car park at Barnham station is very busy and it would be beneficial to displace some of the traffic to Ford.
- 5) The Council would like to see capacity issues addressed to decrease the amount of people that have to stand on journeys to and from London.

We would be grateful if these comments could be fed into your response to Network Rail.

2) <u>Below is the proposed response to Network Rail following the receipt of Members views:</u>

Arun District Council has been consulted on the Network Rail Sussex Area Route Study via West Sussex County Council (WSCC) who is co-ordinating a response from the Local Authorities in West Sussex and other organisations such as rail user and community organisations, as the local transport authority. Arun District Council provided the following response to WSCC to be included within its response back to Network Rail:

Set out below are Arun District Council's comments relating to the improvement of railway infrastructure in the area for consideration by Network Rail.

- 1) Arundel Chord the Council would welcome investigation of whether the Arundel Chord could be used permanently as a regular route to London, with the potential journey saving time from Littlehampton to London of 20 minutes.
- 2) The Council would like to see improvements to the train services from Bognor Regis and Littlehampton to and from London in terms of duration, direct routes and timely availability with investment directed to Arundel and Ford to aid accessibility to and from London for residents of Bognor Regis and Littlehampton. The fast line to Brighton is considered slow.
- 3) The Council is keen for engagement from Network Rail regarding level crossings as it would like to see the removal of level crossings, where possible, and increased safety features such as pedestrian crossing bridges.
- 4) There is a need for additional car parking and a need to improve the existing car parking situation at Ford station. The car park at Barnham station is very busy and it would be beneficial to displace some of the traffic to Ford.
- 5) The Council would like to see capacity issues addressed to decrease the amount of people that have to stand on journeys to and from London.

We would be grateful if these comments could be fed into your response to Network Rail.

In addition to the comments made to WSCC, Arun District Council would also like to take the opportunity to respond directly to Network Rail to raise a few additional, more detailed points. These points are set out below:

- 1) There are concerns that the assessment of the Arundel Chord cost / benefit analysis only addresses journey time factors from Brighton to Horsham, stating that the existing route from Brighton to Horsham via a change at Three Bridges would remain quicker while that is no doubt true, the same analysis does not consider the journey time advantages that would follow any other Coastway West station (Shoreham, Worthing, Angmering etc.) It also doesn't take into account the number of occurrences of Brighton mainline temporary diversions, therefore, appearing to suggest there is always a perfect service on the Brighton mainline.
- 2) There are concerns that all the comparisons in the assessments are entirely rail related and do not take into account other transports / road competition i.e. the A24 would compete with the Arundel Chord and the potential advantages beyond rail have not been taken into account.
- The Arun Valley line is considered by Southern to be a major access route to the South Downs National Park, but it does not have any reference within the study.
- 4) It is welcomed that the study refers to the Arundel Chord, however, it is acknowledged that it is identified as a low priority. It is considered that if the Arundel Chord could be used as a regular route to London, it would allow for

- easier flow of traffic to and from Littlehampton and as a diversion if the Brighton mainline was blocked.
- 5) The plans for Thameslink trains to come to Bognor Regis and Littlehampton should be reinstated.

We would be grateful if these comments could be taken into consideration for the next stage of the process.
