EXECUTIVE SUMMARY:

At Full Council on 8 January 2017, a Motion was submitted calling upon the Sussex Police and Crime Commissioner to review its policing priorities and to urgently invest more human and financial resources in front-line policing.

In debating this Motion, an amendment was agreed and it was resolved that the concerns that Councillors had be responded to by the Sussex Police and Crime Commissioner by attending a meeting of the Council's Overview Select Committee.

The Police and Crime Commissioner, Katy Bourne, will be attending this meeting and will update the Committee on policing in Arun and the Police response to current and future challenges.

This meeting will allow Members to ask questions of concern about policing in the District.

1. BACKGROUND:

- 1.1 As an elected representative, the PCC is charged with securing effective policing in Sussex and to hold the Chief Constable to account for delivering of the Police and Crime Plan.
- 1.2 The PCC is charged with holding the Sussex Police Budget from which all policing of the area is financed and raising the local Police precept via Council Tax collected by billing authorities such as Arun.
- 1.3 The PCC has responsibility for ensuring the priorities set out within the Safer in Sussex Police and Crime Plan 2013-2017 are met. This Plan has four strategic objectives that drive it being:
 - Crime and community safety
 - Victim Focus
 - Public confidence
 - Value for money

- 1.5 These objectives are achieved through engagement with the community, victims and witnesses, business and the voluntary sector; partnership with health community safety partnerships; local authorities; the Sussex Criminal Justice Board and youth offending services and via the Police through neighbourhood policing.
- 1.6 The PCC provides funding for projects and is represented on the Safer Arun Partnership (SAP). The partnership is a body that includes the Police and the County Council. It is chaired by Arun's Cabinet Member for Community Wellbeing. The role of SAP is:
 - "To work in partnership to proactively and reactively reduce the risk of harm and vulnerability associated with crime, disorder and anti-social behaviour for identified individuals, communities and neighbourhoods"
- 1.7 The SAP sets the strategic priorities for the District based on an annual Strategic Intelligence Assessment. The agreed priorities for 2017/18 are:
 - Tackling and reducing Anti-Social Behaviour (priority since 2012)
 - Think Family (priority since 2013)
 - Street Communities (priority since 2015)
 - Serious and Organised Crime: impact and response to County Lines (drugs) and 'Cuckooing' (new priority)
 - Reducing Exploitation: child sexual exploitation, adult safeguarding, modern slavery (new priority)
- 1.8 There has been a notable shift in approaches to community safety over the last five years of the SAP partnership, critically a move away from focusing on reducing volume crimes towards reducing the threat, harm and risk associated with specific types of crime and anti-social behaviour. This shift reflects the increasing complexity of issues within crime and community safety including various forms of human exploitation: modern slavery, child sexual exploitation and human trafficking.
- 1.9 Traditional methods and approaches to tackling and reducing harm, crime and associated problems have needed to be re-evaluated and now encompass a wide array of partners, some of whom may not be traditionally associated with criminal justice functions; particularly housing and health physical and mental wellbeing. These types of harms now require closer working with West Sussex County Council functions (such as social care and safeguarding) and the third sector.
- 1.10 In Arun, a Street Community Multi Agency Assessment Conference is convened monthly and attended by enforcement and support agencies to identify and provide appropriate support for known individuals. Significant results have been achieved in assisting homeless individuals into accommodation, but the support extends to assist individuals in accessing services to support a range of conditions including mental health, drugs and alcohol and financial/benefit advice.

- 1.11 Arun has also been at the forefront of protecting some of the most vulnerable members of our community who succumb to serious and organised crime. Working with the Police, it has been possible to identify individuals who have been targeted in their own homes which are then used for the purpose of storing and dealing drugs. This is a growing problem with obvious risks to Arun's tenants and wider communities and it has become a high priority for the SAP.
- 1.12 In the same category, exploitation in its wider context has been increasing and includes child sexual exploitation and modern slavery. Arun therefore works in partnership with the Police and Social Care to keep vulnerable individuals and communities safe from potential exploitation.
