# **QUESTION ONE**

#### Question

Regarding the letter of the Levelling-Up Minister to Nick Gibb MP dated June 2022, of which the Chairman and all Councillors are well aware, which deals with the opportunities of adding private investment to improve the Levelling-Up project for the Regis Centre, I trust the points in the letter have been discussed with senior Officers such as the Chief Executive, the relevant Service Director and the Regeneration Consultant and that consideration has been given to contacting the Departmental civil servant named by the Minister. If not, why not?

# Response

We have given consideration to this, however, we see no opportunity for private sector investment. Therefore, we don not see the need to contact the named ivil servant.

# **QUESTION TWO**

# Question

The Council has already had to find £3.75m in supplementary estimates to add to the £12.2m Levelling-Up funding for the Regis Centre project. The possibility of having to find further funding must be considered - what contingencies has the Council for this eventuality?

#### Response

The £3.75 m figure is a gross figure rather than a net figure because it ignores any receipts to the council as part of the projects. However, we cannot guarantee that inflation may not run rampant but within the project there is already considerable contingency included.

# **Question**

Regarding the support given by Mrs Latus for the Regis Centre scheme, is that for the 450 seat version and has support from her/the trustees been gained for any later version/have they been consulted?

# Response

Yes, I can confirm that they have and that Mrs Latus sits on the Project Board and supports the revised scheme.
