### Arun Local Plan update | Direction of Travel Document Issues and Options consultation

### Why do we need a Local Plan and what is it?

Arun District Council is legally required to deliver a Local Plan by National Planning Policy. The Plan must identify how Arun District Council will accommodate and prepare for growth in employment, transport, retail and housing.

The Local Plan is also an opportunity to shape change in towns and villages in a sensitive and sustainable way. It will guide the provision of infrastructure to support growth and identify how much and where new housing and economic growth is required.

### What is this consultation about?

As part of the Local Plan process, we need to consult you on the issues and options which the district faces. This has been set out in the Direction of Travel Document which is available on the Arun District Council website.

The Issues and Options consultation is an important part of the Local Plan process. It is the first stage of public consultation, where residents are asked how they would like to tackle a range of planning issues and proposed options for the future development of the district.

We are seeking your views and suggestions on how Arun should grow and develop in the future. This consultation identifies the issues and challenges facing the district and the options that could help address them. We are asking your views on how best to balance the delivery of growth and regeneration across the district to meet future needs whilst at the same time protecting the things we value about Arun. This consultation includes many questions, but you don't have to answer them all. Feel free to pick and choose – you can just answer the questions on the subjects that mean the most to you, \_\_on the other hand you might want to answer them all.

This consultation does not identify potential development sites or draft policies, this will be done at a later stage of the Local Plan process.

### What is the Local Plan process?

The development of the Local Plan comprises various steps and key milestones which are as follows:

### Call for sites

The council asks for suggested sites which might be suitable and available for development in the district.



### Issues and options

(Direction of Travel Document) The council gathers evidence on the needs of the local area and asks for views on different ways in which future development could meet these needs.

### **Regulation 18 consultation**

A draft Local Plan is presented to the public and residents are invited to give their feedback on the draft policies, sites and strategy.



### **Regulation 19 consultation**

The next version of the Local Plan is published and consulted on for 'soundness' - whether it is legally compliant and aligns with national policy, rather than whether people agree with the plan.



The council submits the Local Plan to government for an independent examination.

### Adoption

The Local Plan becomes policy and will be used when determining planning applications.

#### Have your say on the issues and options for the Local Plan

Arun District Council is asking residents, business, and anyone else with an interest in the future of the area, for their views on issues such as housing, jobs, infrastructure, health, climate change and the environment.

All responses will help the council to develop more detailed proposals, which people will be able to comment on in the future.

The consultation runs from Monday 25 March 2024 until 5pm on Monday 6 May 2024.
