1. PURPOSE OF REPORT

1.1 For Full Council to approve a reason for the non-attendance of Councillor Tom Harty.

2. **RECOMMENDATION**

It is recommended that in the event that Councillor Tom Harty is unable to attend a meeting of the authority before the Full Council meeting on 15 May 2024, approval is given to the absence for reason of ill-health of a family member for a period until and including 6 November 2024.

3. EXECUTIVE SUMMARY

3.1 Councillor Harty has been unable to attend a meeting of the Council in recent months due to the illness of a close family member. Councillor Harty attended the Special Meeting of the Council held on 29 November 2023, which is the last date on which he attended a meeting related to the discharge of the Council's functions.

4. DETAIL

- 4.1 Due to the reason set out at paragraph 3.1 of this report, Councillor Harty has been unable to attend a meeting of the Council since 29 November 2023. Under Section 85 of the Local Government Act 1972, if a Councillor does not attend any relevant meeting for a period of six months, they automatically cease to be a member of the Council unless before the expiry of that period the authority has approved the reason for that absence.
- 4.2 The Council is required to consider this matter prior to the expiry of the sixmonth period on 29 May 2024.
- 4.3 It is not currently possible at this stage to say whether Councillor Harty will be able to attend any meetings in person within the near future so Full Council is asked to agree that if he is unable for the reasons set out in paragraph 3.1 to attend another meeting between now and the Full Council meeting on 6 November 2024, such absence will be authorised.
- 4.4 It is noted that whilst Councillor Harty will attend meetings wherever possible, in the event this is not possible this approval will come into force.
