Dear Sirs,

I wish to make a formal complaint on behalf of our petitioners regarding the improper and atrocious manner that Aruns Monitoring Officer dealt with our petition and its representation at the Full Council meeting on 14th July 2021. He has misled our Councillors purposely with false information and used it as a scare-mongering tac-tic. He failed completely to represent our petition in a fair and unbiased manner and we have the paperwork as evidence to prove it. He continues to refuse to release the disclaimed votes for our perusal and has delayed our ongoing complaint prior to the Ombudsman being involved for so long, he is actually out of time.

Arun have refused to hand over 1,300 signatures, which they state are unacceptable and not given reasons as to why. The Monitoring Officer stated on record that the petitioners only wanted the Council to consider revocation only. Absolutely not true. He completely misrepresented our petition statement and final representation statement, which was insisted upon by him. Our statement actually read and included 'Section 97 of the Town & Country Planning Act 1990 (as amended) which reads as follows: 97 Power to Revoke **OR** **MODIFY** Planning Permission'. He did this purposely to mislead the Council members. He also stated on record that the cost for compensation could run to many millions of pounds when in fact, Outline Planning Permission certainly does not have the value that land with Full Planning Permission has. He blatantly supported a figure of around £50,000 a plot, which is so inaccurate, the figure could only have been used to deceive and insure the successful outcome for him and Arun Planning Department.
